We don't control projects; we invest in people. Our on-the-ground Programme Team identifies and rigorously assesses local leaders already transforming lives in their communities. Only a small number of outstanding applicants join The Egmont Portfolio, where they receive funding, hands-on support and long-term guidance to strengthen systems and scale results.

The Portfolio Advantage

The Egmont Portfolio spreads risk and maximises impact by supporting a diverse mix of projects across six countries. This structure also creates powerful opportunities for cross-learning — through roundtables, capacity-building grants and peer exchanges — enabling Egmont Partners to refine models, share innovation and multiply results.

Our monitoring is bottom-up, not top-down. Egmont Partners define what success looks like in their context: keeping children in school, preventing HIV transmission, or growing household income. We work with them to refine and measure those goals. The result is rigorous accountability without bureaucracy, ensuring projects remain rooted in community priorities.

Egmont doesn't avoid risk; we manage it. By diversifying investments and maintaining close, data-driven oversight, we ensure donor capital is deployed efficiently and sustainably.
